In the last two months the RD team participated 2 Web conference calls, one with World Service and one with Our Zonal Forum. There were no Area presentations during this period but I did get married and spent 10 days honeymooning in Mexico!

We will continue in June with more Area Presentations/Feedback and we have been getting good feedback on this approach to Area/Region reach out and information sharing.

The election cycle is now here and the RD team is nominating Billy W for RD and Clarence for RDA. Zoe, the out going RD, has added a thank you note below.

If elected, our agenda for the 2017/18 cycle will be to continue to strengthen Area/Regional ties with more Area Presentations/Feedback, trying to get 2 done each regional cycle(every 2 months). We will also be having the CAR come out

in November and will be running a CAR workshop at Roxboro. With the new focus on WSC Webinars I think we will be seeing much more volume of things asked of us as a region to participate in. More will be revealed. We see our goal as to strengthen

the bonds between World and Region and Region and Areas, increaseing the flow of information and unity.

Also, part of the RD Team's responsibility is to participate in our Zonal Forum, the AZF. July 29th is the next Zonal Forum meeting and it's in Ripley, West Virginia. Here are the costs for our participation(2 people RD/RDA).

Travel Distance- 913.8 miles(456.9 each way) at \$.55 per mile= \$502.59

Tolls= unknown at this time

Hotel- 2 nites(same price for 1 or 2 pers)= \$134.60(\$125 plus tax)

Per Diem(food) at \$55/ day perp person= \$220

Total= \$857.19 plus tolls

Because the cost is so high and the distance so far we propose that only one of us go to this one. Here is what the costs would be:

Travel Costs= \$251.29 \*\*

Hotel= same cost \$134.60

Per Diem= \$110

Total= \$495.89

This Zonal arrangement with costs and travel distances is going to be reevaluated this year. We are going to make some proposal at the Zone about centralizing yearly meeting spots and utilizing more technology(Webinars).

Registration Chair Arlene is working on facility registrations. We have gotten less then we usually do.

Fundraising Committee had their last event the other week in Clean Acres area. This committee worked tirelessly all 2 years and were a huge part in us being financially capable of having this convention.

All merchandise for our convention was picked up. In addition to our merchandise being sold we are also going to have 2 outside vendors selling merchandise that we make a percentage off of.

The program is 100 percent complete other than we need to know what hours should be listed for Regional Workshop. The 4th floor boardroom is where the Regional Workshop will be held. It's available from 11 til whenever on Saturday.

2 things were brought up at our meeting and was asked of me to bring back here.

1) is region or is the convention committee responsible for paying our Insurance Rider? We paid it but some members thought the region paid it in the past.

And the second thing is actually a motion that was passed 7-0-0. The Fundraising Committee made a motion asking that the Region reimburse the Convention Committee the \$6,000 that was taken at the beginning of this Convention Cycle. The intent is to be fully self supporting and to be able to cover any unforeseen costs at the convention.

Hi Family,

The Convention Committee bank account balance as of 05/31/17 and after all checks have cleared should be \$8,929.92. This account balance is true and accurate as of said date.

Since the last RSC Meeting, twenty-four (24) checks were written and disbursed totaling in the amount of \$12,030.86. In addition, there have been nineteen (19) deposits made between 04/01/17-05/31/17 in the amount of \$16,630.52.

Registration Committee Update

- To date, there are 1,342 registrations sold: 995 early bird (\$10) registrations, 62 (\$25) registrations, 48 (\$20) registrations, 237 (\$15) registrations and collection of \$431 in newcomer donations. As of date, twenty (20)

full packages; thirty-one (31) meal/entertainment packages; five (5) Pool Party tickets; thirteen (13) Comedy Show; three (3) R&B Show tickets and two (2) Jazz Brunch tickets have been sold.

- One-site registration will be \$30; and full packages will be \$90. The meal entertainment packages will be \$60 at the Convention.
- As of date, we have received payment for only 37 facility registrations, which is way down from previous conventions. Assuming we get an additional 100 facility registrations, that will leave about 300 registration packets available for on-site registration.

Hotel Committee Update

- Cost to Crowne Plaza Hotel of \$11,000 has been paid in full (\$6,000 Food/Beverage Charge and \$5,000 clean-up fee)
- As of date, the committee has paid \$4,600 to the Crowne Plaza Hotel as a deposit towards to the AV charges/meeting space supplies (i.e. incidentals needed from hotel during the convention). This entire costs still has not been fully established, as we are still in the finalizing stages of our needs for the convention.
- As of date, we have met our contracted room night blockage of 400 and have went over this number by 10 room nights (total 410). This number now brings our percentage of room reservations to 100% of our hotel contract and all meeting spaces are complimentary (free) as per contract.
- Since we were unable to remedy the issue with the tax exemption clause, the sales tax for the Crown Plaza Cherry Hill Hotel is 8% NJ Tax and 5% Service Tax, total of 13%.

Fundraising Committee Update

Convention paid events are as follows:

- Friday, Comedy Show cost is \$15, 200-person maximum (Sold 13 and 187 tickets left)
- Saturday, Pool Party cost is \$20 w/food, 75-person maximum (Sold 5 and 70 tickets left)
- Saturday, R & B Show cost is 430, 200-person maximum (Sold 3 and 197 tickets left)
- Sunday, Jazz Brunch cost is \$15, 100-person maximum (Sold 2 and 98 tickets left)

We are asking all Area Reps to please spread the word about these paid events and help us to maximize the ticket sales.

The Convention Committee is now in the home stretch of finalizing our commitment to the fellowship in putting on a spectacular convention. I would like to thank all the committee members and the Region for allowing me to be a humble servant.
